### **Subscription: 100 euros**

Temporary membership is valid for a boat and its skipper on condition that the following criteria are respected:

- The boat must have been measured at least once and not been modified since her last measurement certificate.
- The boat and team must comply with the Class Rules and Appendix to the Class Rules.
- Temporary membership of a boat and/or skipper is allowed only twice in one calendar year and for races of less than 800 nm. Temporary membership is not valid for the RORC Fastnet Race or for races in the official Class40 calendar.
- A temporary member has no right to vote at Ordinary and Extraordinary General Meetings.
- If in the same calendar year a boat and/or skipper decides to take out annual membership (race > 800 miles), the fees already paid for temporary membership(s) shall be deducted from their cost of annual membership and mandatory annual measurement certificate
- Temporary membership shall be valid for the duration of one race (duration defined in the Notice of Race), for the boat and her skipper.

I hereby request that my application for membership of the International Association of Class40 Monohulls (hereinafter referred to as 'Class40') for the year 2026 be submitted for consideration by the members of the Class Board of Directors.

By joining Class40, I expressly undertake to comply with (i) all the provisions and obligations set out in the Class40 Constitution, its Internal Regulations, its Class Rules, its Measurement Rules and its Permanent Selection System for races imposing quotas, which I declare to have read and understood after consulting them on the Class40 website: <https://www.class40.com/fr/index/> (ii) and in general to comply with all the rules governing and likely to govern the Class40 Association (hereinafter collectively (i) and (ii) the 'Contractual Documents').

I undertake not to denigrate or damage the image of Class40, its actions, its members and its employees or agents, and not to take any action against the Class40 Association and/or its representatives, directors, employees, agents, selection committee members, measurers and/or its members in the event of a dispute concerning the application and/or interpretation of the Contractual Documents or which finds its basis or purpose in said documents or in a decision taken by the Class40 bodies.

I undertake to do my utmost to participate in the life of the Class and, in particular, to attend or be represented at General Meetings.

By joining, I agree to make an additional contribution that may be requested by the class, up to a maximum of €1,000 (ONE THOUSAND euros), in the event that an organiser fails to fulfil their obligation to transfer to Class40 a portion of the entry fees they have collected from Class40 members. The amount of the additional contribution will be set by the Board of Directors after a General Meeting has been held to decide on the matter.

In the event of a breach of these commitments, I am aware that the disciplinary procedure provided for in section 5 of the Class40 association's Internal Regulations may be applied.

I declare that I have read and accept the provisions on page 2 of this membership form concerning the protection of personal data, the link created by my licence with the FFV and the use of my image rights."

### **Protection of personal data**

As part of your membership, the class holds private data about you. This data is held and processed by our administrative department in the context of updating your membership, in order to keep you informed of the class activities and to facilitate your participation in the events on the class program and in the events organised by our partners. In particular, this information may be made available to the organisers of events in which you may be invited to participate.

The association undertakes not to transmit or share your personal data with other entities, companies or organisations other than for the purposes stated above.
